From Troy :

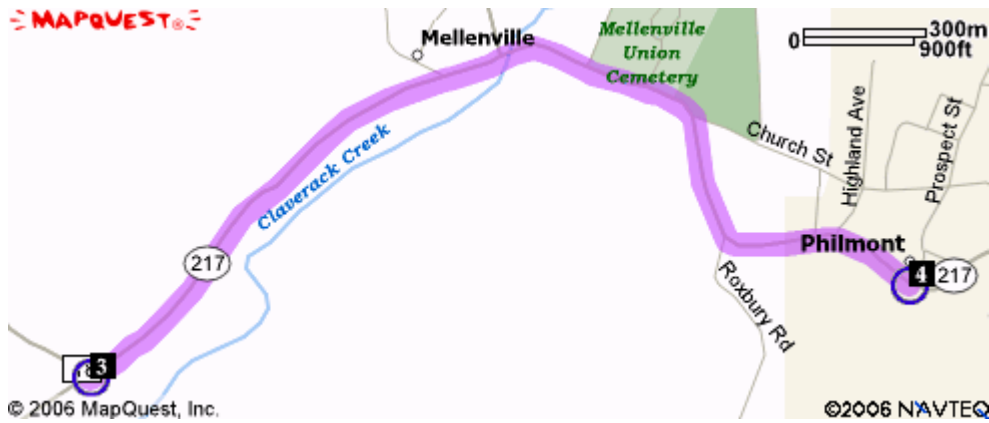
- ❖ I-787 south to I- 90 East
- ❖ Exit 12 - Route 9 South
- ❖ Go to Route 9H south
- ❖ On 9H about 10 to 12 miles
- ❖ Cross over intersection Route 9H and Route 66

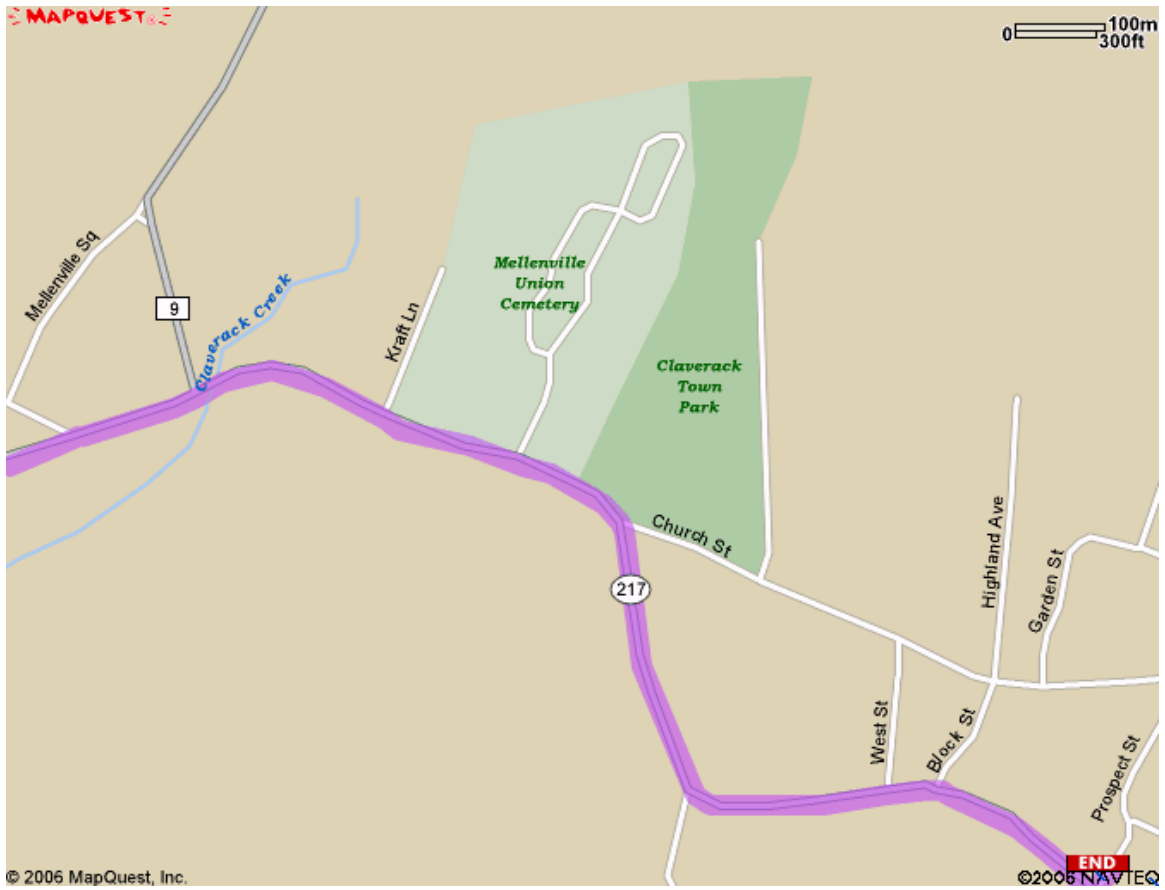


❖ Next Lite Turn left onto Fish Game Road (County 18) to End



❖ Left onto Route 217 into Philmont.





From Pittsfield: (taken from MapQuest) (or you can take I-90 West, off at Exit 12, then follow the first set of Directions)

- **Total Est. Time:** 48 minutes **Total Est. Distance:** 33.51 miles
- Turn RIGHT onto W HOUSATONIC ST / US-20.
- Turn LEFT onto MA-41 / CENTRAL BERKSHIRE BLVD. Continue to follow MA-41.
- Turn SLIGHT RIGHT onto CANAAN RD / MA-295. Continue to follow MA-295 (Crossing into NEW YORK).
- Turn RIGHT onto HARTIGAN RD.
- Merge onto TACONIC STATE PKWY S.
- Take the RT-217 ramp toward HARLEMVILLE / PHILMONT.
- Keep LEFT at the fork in the ramp.
- Stay STRAIGHT to go onto NY-217.
